

SAGF BASIC TERMS

The person responsible for registering individuals or entering individuals for events on their behalf is also responsible for informing those individuals, including guardians, in the case that the individual is a minor, of the below terms and conditions.

CLUBS AND INDIVIDUAL MEMBERS:

1. I hereby declare that I am aware of no reason why I should not be granted the requested membership registration.
 - I undertake to immediately return/update my registration in the event of any substantial change to the circumstances existing at the time of the application for membership.
 - I declare that I have not applied for an additional membership for the same year to the SAGF.
 - I assume exclusive liability for this application and for the use that I shall make of the membership.
2. I hereby undertake to respect the constitution and regulations of the SAGF, its provincial affiliates and of its macro bodies, including SASCOG and FIG.
 - I declare that I have read or have had the opportunity to become acquainted with the aforesaid SAGF constitution and regulations.
 - I shall participate in Gymnastics competitions or events in a sporting and fair manner.
 - I shall submit to disciplinary measures taken against me and shall take any appeals and litigation before the authorities provided for in the regulations.
3. I understand and accept that SAGF will conduct spot checks to verify information.

GYMNASTS:

4. I agree to submit to and be bound by the SAIDS (South African Institute for Drug Free Sport) antidoping regulations, the clauses of the World Antidoping Code and its international Standards to which the SAIDS antidoping regulations refer and to the antidoping regulations of other competent bodies as per the regulations of the World Antidoping Code provided that they comply with that Code.
 - I agree that the results of the analysis may be made public and communicated in detail to my club or team or to my paramedical assistant or doctor.
 - I agree that my doctor or the doctor of my club or team may, on a request from the SAGF, communicate to it a list of any medicines I may take and treatment I may undergo before any given competition.

CATEGORY D REGISTRATIONS BY NUMBER (SCHOOLS AND PRESCHOOLS):

5. I understand, accept and agree that:
 - Category D registrations by Number / Group (non-paying members) submitted by me will require the submission of a stamped and signed declaration by the Principal or Head of the School or Pre-School, as well as a list of gymnasts;
 - Information entered for Category D registration is true and correct. If any information is falsified or cannot be verified by SAGF it may subject me to a disciplinary process.

EVENTS

6. I understand, accept and agree that, should I enter to participate in a SAGF event, be it a competition, course, or any other activity:

- I recognise the inherent hazards that may exist with participation in sporting events, including Gymnastics events, and hereby acknowledge that I will enter SAGF events entirely at my own risk.
- I will commit myself to the prescribed activities, the rules and regulations of the event prescribed by SAGF and its representatives organising the event. I understand that failure to adhere to the prescribed rules and regulations may affect my successful participation in that event.
- In the absence of a full or partial sponsorship towards my participation, I undertake to cover the required costs of my entry to the event that I will be entered for and undertake to pay the full amount by the stipulated due date.
- I will have no claim that may arise either directly or indirectly of whatsoever nature and whatsoever cause against the SAGF / ORGANISERS or any of its affiliated bodies or persons, should I suffer any loss/injury as a result of my or the minor's attendance or participation to any SAGF event and everything relative thereto, including my travelling thereto and back.
